

BRETT HUNTER AIRSHOWS

Operational Requirements

Fuel: Enough fuel to fly the show and top-off upon completion of show. Show aircraft requires ten (10) gallons per show flight. A maximum of twenty (28) gallons is required for departure. Grade 100/130 or 100LL.

Engine Oil: One case (12quarts) Aeroshell 100.

Smoke Oil: Six (8) gallons per flight, (to include practice flights) of any of the following is acceptable: Aeroshell Vitrea 13, Canopus 13, Corvus Oil, Standard Oil Facto 39, Texaco Regal B, Sun Oil Circle X, Shell Carnea 10 or 22, Union Oil Unax 105, Gulf Oil 370, Arco Duro-S 105, and Exxon Faxam 40. Smoke oil must be available with a convenient method for transferring it to the aircraft smoke oil tank, such as a hand pump and hose.

Covered Parking: Required for aircraft for duration of show. The Pitts is 20 feet long and 20 feet wide and 6 feet tall. Crowd control is required such that the performer aircraft is protected at all times.

Lodging: One (1) non-smoking room starting with day of arrival until departure.

Ground Transportation: One (1) full-sized, insured, air-conditioned vehicle to be available upon arrival at show location.

Fees: **Two day show:** \$6,500.00
Each additional day: \$400.00 per day
Travel expenses: To be negotiated

Deposit: A one Thousand(\$1000) deposit will be required to confirm booking. The balance of the fee is payable prior to the briefing on the last day of the event. Checks should be made payable to Brett Hunter.

Cancellation Policy:

1. Performer cancellations prior to the show, for any reason, will return the entire deposit. Cancellations after one or more performances, fifty percent (50%) of the balance shall be payable to Brett Hunter.
2. Airshow cancellations, for any reason, shall be payable on a pro-rated basis. The balance (100%) will be payable if cancellation notice occurs less than two weeks from the scheduled appearance and will be reduced by twenty percent (20%) for each additional thirty days (30) notice.

Insurance Information: Airshow Liability Insurance in the amount of one million dollars (US\$1,000,000.00) is carried.

AIRSHOW AGREEMENT

Brett Hunter agrees to provide the following:

1. AEROBATIC PERFORMANCE is 11- minutes; one performance per airshow day unless otherwise arranged. (Circling jumpers, fly-by's etc. can be included at the airshow sponsor option.)
2. LIABILITY INSURANCE (A Proof of Insurance Certificate will be sent upon request.)
3. PRESS KITS (Airshow sponsor to specify amount at least 14 days prior to required mailing.)

4. One air-conditioned rental car from day of arrival to time of departure.
5. \$6500 (US funds) Air Show PERFORMANCE PRICE
6. 0 (US funds) TRAVEL expenses.
7. \$6500 (US funds) TOTAL OF ALL PAYMENTS. Make check payable to Brett Hunter.
8. \$1000 (US funds) DEPOSIT to be disbursed to confirm.
9. \$5500 (US funds) BALANCE to be disbursed not later than one hour after final performance.

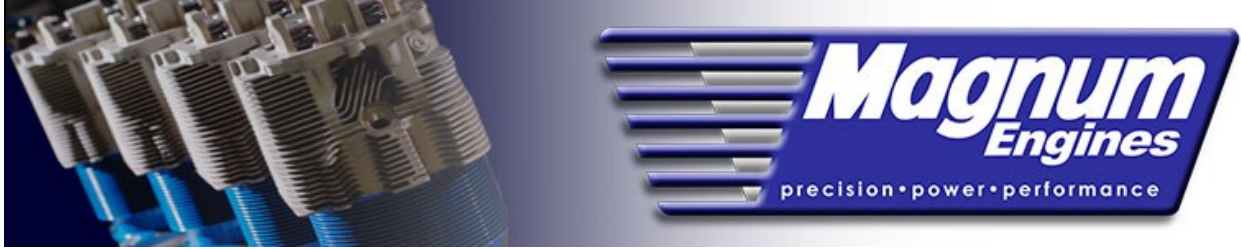
